



The price-list for self-payers is intended for clients who are not insured by any of the health insurance companies in the Czech Republic.

A fixed conversion rate used for payments in € is **25.750** CZK.

- **Surgeries and therapeutic procedures** can be paid in cash or by credit card (EUR, CZK).
- **Medication** can be paid in cash or by credit card (only CZK).

## CYCLE WITH DONATED EGGS WITH GUARANTEE

- **THE PRICE INCLUDES:**

- Consultation and ultrasound examinations during the treatment cycle
- Costs associated with the stimulation of the donor (monitoring of the donor's cycle and obtaining eggs, the medication for the donor, reimbursement of a donor)
- Tests for HIV, hepatitis B, hepatitis C and syphilis for the client's partner
- Partner's sperm analysis + freezing and preservation for 1 year (necessary to request in advance)
- [ICSI](#), [extended cultivation](#), ev. [assisted hatching](#)
- Embryo transfer
- The guarantee program** secures that the client receives at least 6 mature oocytes from the donor or 2 embryos which are suitable for transfer (3rd day of cultivation). All this on condition that the sperm quality is sufficient (normozoospermia according to WHO standards). If we fail to comply with this guarantee and the client does not become pregnant (confirmed heartbeat), we automatically offer the client another cycle for free.
- Third cycle for free** for clients who do not become pregnant (confirmed heartbeat) in our clinic even after two cycles with donated eggs (after transfer of all embryos produced during these cycles), provided that the semen quality was sufficient in both cases (normozoospermia).

## CYCLE WITH FROZEN DONATED EMBRYO WITH GUARANTEE

### ■ THE PRICE INCLUDES:

- Consultation and ultrasound examinations during the treatment cycle
- The costs associated with the donation (incl. the medication for the donor and examinations)
- Price per 1 embryo € 1,400**
- Price per 2 embryos € 2,800**
- Guarantee of an embryo** suitable for transfer on 5th day of cultivation (blastocyst) + assisted hatching if necessary.
- Guaranteed priority order** in the case of unsuccessful thawing of embryos. The payment is only charged for actually transferred embryos
- Third cycle free of charge** if the client does not become pregnant (confirmed heartbeat) in our clinic even after two cycles with donated embryos, provided that there were two blastocysts transferred each time during the 1st and 2nd cycle with donated frozen embryos. The client is thus entitled to a transfer of two blastocysts free of charge in the third cycle.

## SURROGACY

- When using a surrogate mother, there is a surcharge to the selected therapeutic cycle of **€ 1,300**
- This surcharge includes the preparation and the treatment of the surrogate mother without drugs and blood tests. Surcharge also includes one consultation with legal counsels.
- Requirements for implementation of surrogacy:
  - Medical indication
  - At least one of the partners must be biological parent of the child
  - Both the surrogate mother and the mother of the future child must have Czech citizenship
  - Approval of GENNET ethics committee
