

## IVF PRICE LIST

### Insured

**This price list is valid for clients who are insured by health insurance companies in the Czech Republic.**

When the client is entitled to reimbursement from health insurance, the cycle is directly charged to the insurance company.

(According to § 15 section 3 of the Public Health Insurance Act No. 48/1997 Coll. the treatment related to in vitro fertilization is reimbursed three times in life at the most, or when in the two first cases only 1 human embryo was transferred into female genital organs, then four times in life). Artificial insemination is covered by health insurance until the woman's 40th birthday. Cancer patients are fully covered for freezing of eggs (oocytes) once in their lifetime.

**Special laboratory methods are directly paid by the client as well as additional payments for stimulation drugs or drugs that are not included in the limit of the health insurance (after using up 2250 IU).**

### PRICE INCLUDES:

- ✓ Consultation and ultrasound during the cycle.
- ✓ Costs related to the donor (monitoring of donor cycle and oocyte collection, drugs for the donor, reimbursement of the costs of the donor).
- ✓ Testing for HIV, Hep B, C and Syphilis for the male partner.
- ✓ Semen analysis and freezing of the partner's sperm plus storage for 1 year (upon previous request).
- ✓ ICSI, extended cultivation, assisted hatching if required.
- ✓ The first embryo transfer
- ✓ 1 hour of psychological counselling in Czech
- ✓ **This program guarantees** our clients at least 2 embryos in blastocyst stage (5th day of cultivation) assuming that the sperm quality is not qualified as OAT (oligoasthenoteratozoospermia) or worse (according to the WHO). In case that the patient receives only 1 blastocyst and does not get pregnant (confirmed heartbeat), we create at least 1 more embryo in asynchronous cycle (it means that the patient receives at least 1 additional embryo from oocyte of another donor).
- ✓ In case of asynchronous cycle, the frozen embryo transfer is charged according to the valid price list. The fee for vitrification is charged in case that there are 2 or more embryos frozen during the asynchronous cycle.
- ✓ **Third cycle for free** for clients who do not become pregnant (confirmed heart action) even after two cycles with donated eggs with the 3rd cycle guarantee (after the transfer of all embryos formed during these cycles) and the sperm quality was not qualified as OAT or worse in both cycles (according to the WHO).
- ✓ The patient is entitled to the 3rd cycle free of charge for a period of 12 months from the last embryo transfer.

### PRICE DOES NOT INCLUDE:

- × Vitrification of embryos + the preservation of embryos for 1 year
- × Other additional laboratory methods (depend on the advice of the physician /embryologist and wish of the client).

### PAYMENT PROCEDURE:

- **20 000 Kč** upon the treatment date confirmation.
- The payment for the treatment must be completed on the day of donor's egg collection at the latest.

## CYCLE WITH DONATED EMBRYOS

### PRICE INCLUDES:

- ✓ Consultation and ultrasounds during the cycle.
- ✓ Costs related to donation
- ✓ **Guarantee of an embryo** suitable for transfer on 5th day of cultivation (blastocyst).
- ✓ **Guaranteed priority order** in the case of unsuccessful thawing of embryos. The payment is only charged for actually transferred embryos.
- ✓ **Third cycle free of charge** if the client does not become pregnant (confirmed heartbeat) in our clinic even after two cycles with donated embryos, provided that there were two blastocysts transferred each time during the 1st and 2nd cycle with donated frozen embryos. The client is thus entitled to a transfer of two blastocysts free of charge in the third cycle.
- ✓ In all remaining cases, the client is entitled to 1 blastocyst for transfer in the third cycle.
- ✓ The patient is entitled to the 3rd cycle free of charge for a period of 12 months from the last embryo transfer.
